Respite @ Shore is a respite service that aims to prevent escalation of suicidal feelings and self-harm in people living in the Brighton and Hove area who have mental health problems, problematic substance use and/or complex needs. It seeks to provide an empowering and preventative service to those who may without it require hospital admission/use of a statutory crisis mental health services.

Client involvement and empowerment are central to our approach.

Job Summary

A Bank Cover Worker at Shore House will provide support and practical assistance using the recovery model.

The role will involve supporting residents of Shore House and guests of the respite service in a variety of areas, including managing their mental health, maintaining their living spaces, attending appointments, and providing emotional support and meaningful positive contact time.
