# **Project/Department Summary**

BHT Sussex Advice Services are made up of the projects detailed below. All services deliver on more than one contract.

#### Brighton and Hove Advice Services

Our Advice Services in Brighton and Hove provide legal advice on housing, asylum, and related social welfare matters. The service consists of the following:

• A Housing Legal Advice Team – currently consisting of a Team Leader who is a qualified solicitor, a Housing Solicitor, a Senior Housing Adviser, two Housing Advisers, and a Reception/Triage Worker.

The Housing Team's main contracts are with the Legal Aid Agency and Brighton and Hove City Council to deliver advice and include a Housing Possession Court Duty Scheme. BHT Sussex Advice services are a partner in the Advice Matters project and the Moneyworks project within the city.

 An Asylum and Immigration Legal Advice Team – currently consisting of a Team Leader who is a qualified solicitor, 3 Immigration/Asylum Solicitors, a Senior Adviser and 1 parttime Adviser. The Asylum and Immigration Team has a contract with the Legal Aid Agency to deliver advice on asylum and immigration matters.

• The two teams are supported by two Legal Secretaries/Administrators.

#### East Sussex Advice Services

BHT's East Sussex Advice Services are based in offices in Eastbourne and Hastings.

#### Eastbourne Advice

The service consists of the following:

- A Housing Advice Team currently consisting of a Team Leader who is a qualified solicitor who works across the Eastbourne and Hastings offices. An Eastbourne Advice manager who also provides housing advice within the Eastbourne office and 1fte Housing Adviser (funded by the Legal Aid Agency, Eastbourne Borough Council and Lewes District Council)
- Debt advice 1 adviser funded by East Sussex County Council covers the whole of East Sussex.
- Macmillan East Sussex Welfare Benefit Service 2fte and 0.5fte Administrator (funded by Macmillan Cancer Support and delivered in partnership with Money Advice Plus)

#### Hastings Advice

The service consists of the following:

 A Housing Advice Team – 1.8fte Housing Advisers and a Manager (funded by the Legal Aid Agency, Hastings Borough Council and Rother District Council)

### Job Summary

The post holder will provide specialist housing advice to clients who are eligible for assistance under a Civil Legal Aid Agency Contract, as well housing advice to residents of Hastings and Rother where they are not eligible for Legal Help.

The post holder will be a specialist housing adviser who has experience of Housing/Homelessness Law. Ideally the post holder will also provide advocacy in the county court on housing possession matters, e.g. at the housing court duty possession scheme;

# Salary

The salary is paid monthly in arrears and will be £24,502 to £29,349 per annum depending on experience. An employer's pension contribution of between 5.5% is also paid. The level of this contribution is reviewed annually.

### Hours of Work

The hours of work will be between 37 hours per week, working Monday to Friday. BHT does not pay overtime but will grant "time off in lieu" if agreed by the Hastings Advice Manager.

### **Annual Holidays**

The annual leave entitlement will be 185 hours (25 working days) pro rata, rising 1 day for each year of service to a maximum of 222 hours (30 days) pro rata. The role will include working on some bank holidays as part of the team rota for which "time of in lieu" will be granted.
