Why support BHT Sussex?

BHT Sussex is a highly valued and trusted charity working to combat homelessness, reduce poverty, and improve mental wellbeing. Through partnerships with local councils, the NHS, and voluntary organisations, we empower thousands of people every year to rebuild their lives.

We work across Sussex, with services in many areas such as Brighton and Hove, Hastings, Eastbourne, Haywards Heath, Burgess Hill and Crawley.

Founded in 1968, for over half a century BHT Sussex has delivered specialist services including supported accommodation, residential rehabilitation, mental health support, housing and legal advice, employability initiatives and safe housing for marginalised people with complex needs.

Our impact last year in numbers

10,683 clients and tenants supported





198 people accommodated in our specialist mental health supported housing

2,273 people helped by our advice centres in Brighton, Eastbourne & Hastings





2,142 cases of homelessness prevented

6,603 visits made to First Base, our resource centre for rough sleepers





1,838 people supported by our community mental health services in West Sussex

463 individuals and households accommodated in our community housing



Real life story: Samuel



Samuel came to First Base, our day centre for people sleeping rough, after a series of devasting events left him homeless. Following his daughter's death from Covid-19, he started to drink to cope with the grief. He lost his job and his benefits stopped, leaving him unable to pay his rent. He was given 24 hours' notice by his landlord to leave.

"The first time I came here [First Base] I was very surprised. I sat with one of the workers and I felt I could open up to her. She was the first person I spoke to about my daughter. I had no other family, and to be honest I felt like there was no way out. But talking to her helped."

"She helped me sort out my benefits and referred me into accommodation. Things started to change in my head; I began to see a way out."

"I've completely stopped drinking for the last 6 months. I'm feeling good about my accommodation, and I get on well with my flatmates and my keyworker."

"I want to get back into work. I've started coming to a cooking group every week at First Base where we cook a meal for the clients. I'm in the right place now."


Why partner with us?

Partnership opportunities

Frequently asked questions



How are donations used?

Every pound donated is reinvested into our services, directly benefiting those in need.





Charity sponsorship payments are different from donations because your company gets something related to the business in return. You can deduct sponsorship payments from your business profits before you pay tax by treating them as business expenses. Payments qualify as business expenses if BHT Sussex:

- publicly supports your products or services
- allows you to use our logo in your own printed material
- allows you to sell your goods or services at our event or on our premises
- links from our website to yours



If you're unsure whether a charity payment qualifies as a sponsorship payment or a donation, contact the HMRC charities tax helpline.

What commitment is required from corporate partners?



Support can be financial, through employee engagement, or through gifts in kind. We offer flexible involvement to suit your business and your budget. We'd like to encourage multi-year commitments but are grateful for any support you can offer.

How can we get involved beyond financial support?
